2. Nature of Practice

Emergency / Ambulatory Outpatient care for Cape Coral Hospital.

3. Location of Practice

IV. General areas of Practice

Nurse Practitioners as employees of Cape Emergency Physicians Inc., will provide health care to presenting clients. Medical acts of diagnosis, management, and treatment will be based on the ARNP/FNP's educational preparation and experience.

The nurse practitioner will promote high-level wellness in the individual, family and community through health promotion, illness prevention, and management of acute and chronic health problems.

V. Specific Management Areas

All of the below functions may be performed under general supervision.

1. Perform comprehensive and periodic assessments and physical exams of clients to determine their physical, emotional, and social needs.
2. Establish medical diagnoses and plan of treatment of acute and chronic health problems.
3. Order, obtain, perform, and interpret routine laboratory and diagnostic studies; perform minor surgical procedures.
4. Initiate, monitor, alter, order, and prescribe drug therapies in all classes based on the ARNP/FNP's educational preparation and experience. Controlled substances can not be prescribed.

Pursuant to this Collaborative Practice Agreement and Protocol and as approved by the hospital's Medical Staff, the nurse practitioner may, in the hospital setting only, initiate, monitor, alter, or order controlled substances which are within the scope of training and knowledge base of the nurse practitioner.


5. When indicated, the ARNP/FNP will obtain appropriate evaluations, consultations, and make referrals.


VI. Duties of the Collaborative physician and or his designees:

2. Be available on-site, by pager or telephone 24 hours/day when practitioner is on duty.
3. Be available for consultation on specific patients as the need arises.

VII. This agreement will be reviewed on annual basis.


